

Registration Agreement Neuro4D Meeting

Scope of Agreement

The working language of the Event is English.

This agreement constitutes the entire agreement between bioExpert ('bE') and the delegate ('Delegate') regarding registration and participation in the Neuro4D Conference to be held in Mainz, Germany May 11 to 12 2020 (hereinafter the 'Event').

bE reserves the right to adapt the program and content of presentations, poster sessions and panel discussions. Should the Event be cancelled or the location be changed for reasons or circumstances beyond our control, we reserve the right to reschedule the Event, including changing the location, upon written notice to you. Should the event fail to be rescheduled for any reason Delegate will be refunded all moneys received by bioExpert from Delegate for the Event.

Event participation is personal, however, you may request changes to delegates prior to the start of the Event. Nonappearance of Delegate will not affect your obligation to pay the conference fee. No persons other than those officially registered may attend any part of the Event.

Delegate warrants and represents that his conduct or any information provided and presented will not contain anything that is defamatory, obscene, false or misleading, or otherwise violate any intellectual property rights, or rights of any person, and will not violate any applicable law or regulation.

Delegates are responsible for their own insurance (including, but not limited to, travel insurance, personal effects and personal insurance), and visas. Delegates are responsible for their own travel arrangements.

Payment

Academic Registration Fee, is for proven academic or student participants. It includes participation for the entire Event including arranged meals and drinks, but no accommodation:

Cost before February 15: 590 EUR

After February 15: 790 EUR

The **total fees specified here above are subject to 19% German VAT**, which shall be payable in addition,

as the event is taking place in Germany. Delegate is required to submit full payment of the conference fee within 5 days of the date of the invoice. Registration will not be issued until the full contractual amount has been received.
